Waiver of Deposit for Active Duty Military Personnel

NOTICE:

Active Duty military personnel (National Guard and Reserves personnel are ineligible) must present the following items at the time of application:

- Proof of purchase (mortgage agreement, warranty deed, tax receipt, payment coupon book) or lease/rental agreement
- Full name, Social Security Number and valid U.S. driver's license (or other government-issued identification) for all persons listed on the proof of purchase or lease/rental agreement
- Current Active Duty military transfer orders showing assignment to the Montgomery area, commanding officer and tour of duty information

Water service will be initiated by the close of the next business day upon submission of this completed application and the required items listed above. The Water Works & Sanitary Sewer Board will add a \$30.00 New Service/Transfer fee to the first month's bill. If same-day service is required, a fee of \$50.00 will be assessed, and must be paid in advance. This request may be submitted in person at one of the Water Works locations listed above, by mailing it to P.O. Box 1631, Montgomery, AL 36102-1631 or by fax at (334) 240-1689. If this request is submitted by mail, please allow 5 - 7 days transit time before water service is initiated.
